The inaugural Malaysian Law Conference was declared open by the then-Prime Minister of Malaysia, Tun Abdul Razak Hussein, on 15 July 1971. With the rapid advancement of the Malaysian economy and the meteoric rise of Asia, the Malaysian Law Conference evolved to keep up with the times.

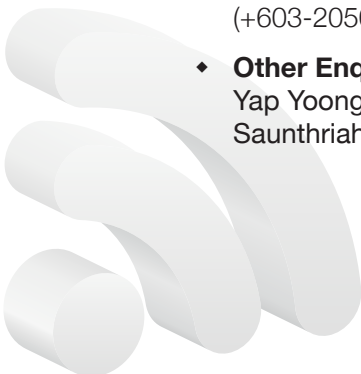
In 2012, the Malaysian Law Conference was re-branded as the International Malaysia Law Conference, a turning point in the history of the series, establishing a new paradigm in the present era of increased globalisation.

The IMLC logo consists of a segmented circle with gradients of shades of blue. 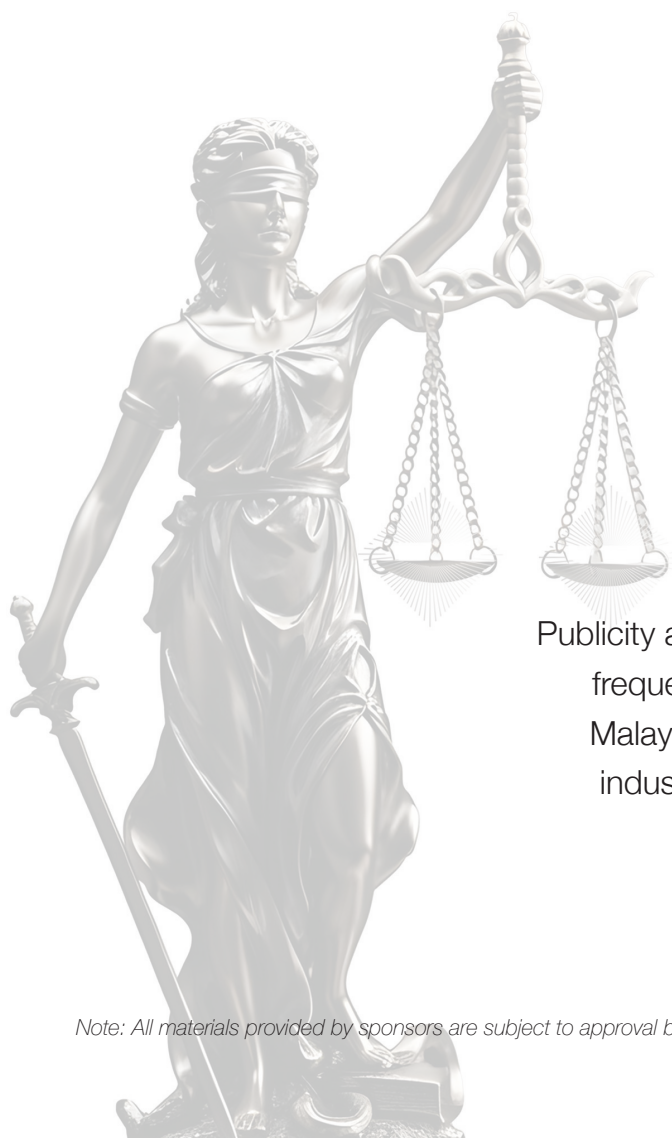
